Gentleman,

The grievance Appeal bearing Registration No. MORTH/E/A/25/0000048 dated 06.01.2025 has been examined with reference to the original grievance No. No.MORTH/E/2024/0018023 dt.15.12.2024 and reply furnished to you by PD, PIU, Amaravathi vide letter No.1887 dated 18.12.2024.

- 2.1 Now, PD, Amaravathi vide Lr. No.86 dt.13.01.2025 submitted the report as follows:
  - (i) Shri R. Gowardhan had purchased land for an 200 sq yards in Survey no. 51/A of Chinnakakani village, Mangalagiri Mandal, Guntur District, AP in 2019.
  - (ii) The same land was acquired vide Award no. 06/2013 in 2013 but due to officials mistake, he had purchased land in 2019, as the survey number & extent was not blocked (not carried out change of right of records).
  - (iii) The project work was commenced at the time of passing of award
  - (iv) Even though project cost increased many times but compensation awarded is very low.
  - (v) The petitioner claims that due to the failure to carry out a Record of Rights (RoR), he purchased land that had already been acquired for the National Highway project and has not received any compensation for it.
- 2.2 As the issue raised in the petition was with respect to acquisition of lands for 6-laning of Gollapudi Chinnakakani section of NH-16 (Pkg.IV)" and mutation. And the petition falls within the jurisdiction of Competent Authority (LA) & Sub-Collector, Tenali and not within scope of NHAI, as such the CALA was requested vide PIU letter dt.18.12.2024, to take immediate appropriation action for resolution.

- 2.3. It is to inform that the petition has been marked as closed "duly enclosing a copy of PIU letter addressed to CALA & Sub-Collector, Tenali," as there is no provision for transferring the petition from NHAI to the Competent Authority (LA) and Sub-Collector on the CPGRAMS portal.
- 3. It is observed that PD has properly replied, the grievance.
- 4. Hence, the Appeal stands disposed off.
